- Background about Remand Prisons and CIDs
 

In Sana'a- Municipality, there are four remand prisons which are as follows:

  - Alayah Prison with the capacity of 250 prisoners and currently accommodates 450 prisoners.
  - Althawrah Prison fits for 220 inmates and currently has 400 prisoners.
  - Habra Prison with capacity of 220 prisoners, currently has 420 prisoners.
  - Mo'alemi Prison with the total capacity of 220 prisoners, currently has 370 prisoners.
  - Criminal Investigation Prison fits for 100 prisoners and recently has 171 prisoners.

On March 25<sup>th</sup>, 2016 , Sajeen Foundation formed human rights committee composed of six members to pay field visits to remand prisons and criminal investigation prison in Sana'a- Municipality. The Committee initiated its functions on Monday, March 28, 2016 at 8:00 a.m. through visiting Alayah ,Habra , Althawrah ,Mo'alemi remand prisons as well as Criminal Investigation Prison. Accordingly, the committee submitted a report stated that the most prominent needs of prisons were as follows:-

- lack of power in prisons.
- Shortages and inadequate food for prisoners.
- Sewage outfall due to clogged toilets.
- Almost entirely lack of medicines and medical supplies in prison clinics and pharmacies.
- Cooking tools are worn-out and unfit for use.
- Substantial shortage in use water
- Potable water is unfit for human consumption, moreover insufficient.
- Prisoners cannot change their clothes due to scarcity and inability to purchase.
- Blankets and mattresses have become unfit for use and totally worn-out.
- Obvious violations and maltreatment of prisoners by jailers seen in (meals delay – abusive words – medicine delay of some cases – Lack attention to hygiene... ) Etc).
- Many issues neglected by courts.
- Many political prisoners had been concealed from their families that know nothing about their prisoners' whereabouts.

- **Report Summary**

Project aims to alleviate the suffering of the prisoners in remand prisons and criminal investigation prison located in Sana'a-Municipality through ensuring access to food ,kitchens necessary tools, alternative electrical power as well as conducting cleaning campaign for the internal and external facilities of remand prisons and criminal investigation prison jointly with providing hygiene materials and NFIs, hygiene awareness campaigns and full maintenance of prisons' sewers and sanitation system.

Project benefited (1771) prisoner through covering the prisoners' nutritional needs for a month, kitchen requirements for a year, and provide alternative electrical power for seven years (the lifetime of the installed solar system).

- Hygiene:

Hygiene campaign was implemented in remand and investigation prisons; (Alayah, Habra , al-Thawrah , and Mo'alemi) conducting the following:

1. Full internal and external cleaning of prisons
2. Full internal and external wash of prisons
3. Providing hygiene kits for inmates.
4. Maintenance and cleaning of the whole prisons' sewer

• Recommendations and Suggestions:

- Forming Human Rights Committee to follow up the outstanding issues of male and female prisoners at procuratorates and courts.
- Confining prisoners who cannot pursue their cases due to inability to pay for the elevator before the courts and procuratorates so to be included within the Judicial Support Project in Sajeen Foundation.
- Communicating with Municipality (Hygiene and Environmental Improvement Sector) to coordinate work nationwide for conducting a thorough cleaning campaign for all remand , criminal investigation and police stations prisons in Sana'a-Municipality
- Forming a health committee to assess the health condition in prisons in the municipality and report the health requirements to Ministry of Health.
- Setting a medical camp to examine and treat diseases spread in remand prisons and prison for forensics.
- Coordinating with Ansar Allah to allow some prisoners' families to visit their prisoners.
- Providing mattresses and blankets for prisons and elimination of the useless previous ones
- Contacting with Water Ministry to provide safe drinking water and use water .
- Communicating with the Ministry of Education and Ministry of Higher Education to coordinate for the students enrolled in schools or universities to continue their education.
- We urge the Ministry of the Interior, which is legally responsible for prisons to act towards it and do its legal and humanitarian duty towards an invisible segment of society that is behind bars.
- We call on all the businessmen and civil and international organizations to bear their humanitarian responsibility towards prisoners and their families that suffer deteriorated humanitarian situation and considered as vulnerable and forgotten segment left behind bars with families left with no sponsor.
- We call for holding a workshop with the presence of prosecutors and courts in which to be discussed extensively remand prisons' conditions in various fields , so to be able to come up with a unified vision to alleviate human suffering in prisons and the possible solutions that do not interfere with the dictates of law and preserve the prisoner's dignity and maintain their rights
