We Expect Much from the Philanthropists and International NGOs

Four years of hard work dedicated for male and female prisoners in pursuit for their freedom and defending their basic forgotten rights, in particular the insolvent prisoners who have served their sentences long ago and may remain jailed for more years.

2016 was extremely difficult and full of suffering for all Yemenis living under the brutal aggression practicing unjust sea, air, and land blockade preventing access to food as well as the deliberate destruction for everything around. Such brutality left Yemenis in very harsh living conditions unable to have the basic living requirements, let alone prisoners. Within such context, prisoners, who are basically a forgotten segment lack powerlessly the very basic needs. Add to that, the suffering of their families who face hunger and oppression due to the absence and unjust jailing of their breadwinners who kept in prison more than the due jailing time on the basis of inability to pay off debts for being in prison. Thus, Judiciary shall review and amend the laws so the prisoner can pay off the dept.

Unfortunately, Yemeni community considers the prisoner a criminal with no rights even though with having just cases such blood money, compensation for injuries, and debts. Prisoners have been disgraced by the community in a manner stands as a difficulty before the prisoner to attain freedom, restore respect, and enjoy full citizenship rights. Add to that, the ongoing suffering of long proceedings that my exceed 3 years just in the Court of First which can be considered as a main cause of prisoner and his/her family insolvency.

Thus, as such segment is living under community and media injustice, we have attempted to work tirelessly to raise community and state agencies awareness-towards such forgotten group. National Prisoner Foundation (NPF) not only adopted prisons and prisoners' issues ,but also strived to enhance their image within communities, provide care while being in prison , care about their families through food, health, and shelter services provision. their stay in the prisons, then after their release, as well as to care for their families to distribute baskets of foodstuffs, materials, health and education services, in addition to psychological support to relieve their suffering due to the absence of their breadwinner.

Therefore, We expect much from charity people and international organizations which have good fingerprints in helping Yemenis . We call them to work together to help thousands of worthy insolvent prisoners to get their freedom, enhance prisons' inside condition through prisons' workers and prisoners training on income-generating activities considering prisons laws amendment on the basis that prison is not a place of taking revenge from wrongdoers, but rather a mean of correction and rehabilitation so the prisoner turn to be a good productive member of the community for the benefit of Yemen.

I call upon all the relevant authorities to attempt finding independent companies to operate laboratories within prisionand to consider hiring prisoners and shall be run independently away from state so to reflect positively on prisoner, his/her family, and on community as well.



National Prisoner Foundation release 138 prisoners from penitentiaries pinching Sana'a - Alamanah and seven provinces during the year 2016





National Prisoner Foundation released 138 prisoners during 2016. who had been imprisoned in the Cen-Correction in (Alhodaidah. AlMahwit, Hajja, Dhamar, Sana'a, Aden, and Ibb) at a cost of 130 million Yemeni riyals.

A report issued by NPF said that payment financial program was for insolvent prisoners, which implemented within the protection program during the 2016 included 138 insolvent male and female prisoners. They were released after intensification of efforts and communicate with businessmen and philanthropists to provide special rights for insolvent prisoners.NPF negotiated with rights owners who collaborated taking some of the funds for the benefit of insolvent prisoners.

The report pointed that NPF has worked to release insolvent prisoners on multiple time periods during 2016 releasing of 86 prisoners from the prisonsof Sana'a and Sana'a governorate.

Also the report pointed out that 11 insolvent prisoners were released from the Central Correction of Alhodaidah governorate and 6 other prisoners have been released from the Central Correctionof AlMahwit governorate. The report noted that NPF has worked on the release of 12 prisoners in the Central Correction of lbb governorate and three insolvent prisoners from the Central

Correction of Dhamar, Aden, and Hajjah. The report indicated that a team of lawvers and jurists have worked on to follow up &study of insolvent prisoners cases taking into consideration compatibility with NPF measures including insolvent prisoners fair cases, humanitarian conditions, and legal terms. NPF Secretary-General ,Mr.Yahya Ali Alhabbari reported that the great attention for insolvent prisoners by NPF, comes within the protection program which aims to help the insolvent prisoners and their families to get back their normal life and protection of their families after long absence behind bars.

In turn, NPF General Manager, Mr. Fadel Obaid noted that the insolvent prisoners' project consists of several stages before the financial payment on behalf of the insolvent prisoner. It started with survey and study of the prisoners' files ensuring compliance with NPF standards, followed by attempt to negotiatethe private rights'owner, then issuance of a list detail the preferences and list the most needed insolvent prisoners for assistance that conducted through arranging with procurators to pay the private rights on prisoners and close their files with public prosecutors and courts.

Judicial Assistance Project Stand for Prisoners Pending **Cases in Courts**



National Prisoner Foundation implemented survey of prisoners in need of assistance in Central Correction as well as Womenand Juveniles Prisons,in Sana'a within its judicial aid project.

Mr.Fadel Obaid, NPF General Manager, and Mr. Mohammed Salah, Vice Chairman of the Chamber Commerce reviewed the situation of prisoners in Almoalimy Correction to help insolvent prisoners and provide attorneys to plead their cases. Deputy Chairman of the Chamber Commerce emphasized that Chamber of Comto support prisonmerce is ready ers issues and arrange ways to pay for number of cases with businessmen members of the Chamber of Commerce.The aim of the Judicial Aid Project, which has spread throughout the year to determine people with just causes unable male and female insolvent prisoners to assign lawyers to defend them. A team of lawyers who volunteered to work with NPFconducted field visits to Correctional Prisons and interviewed prisoners to identify the cases to be presented before the procurators, courts and legal assistance. Mr.Fadhl Obeid, General Manager, confirmed in a statement on the importance of coordination and partnership with all concerned and human rights organizations to consider the major deferred and bit speed and in the achievement of human justice and facilitating judicial proceedings.He pointed to the importance of society pressure and shed light on forgotten prisoners who have not been summoned for interrogation or trial.During his survey visit, Colonel Ahmed Madhkor, General Manager

of Sana'a reform branch, confirmed to facilitate the legal team 's mission and provide data of prisoners and their issues. He pointed to the need of communication with the Public Prosecutions with respect to jurisdictional offices and temporal issues and duration of legal confinement, which does not exceed six months in cases of serious crimes in addition to activating the obligatory release.Mr.MalikSharaf al- Din, the legal affairs director of the foundation of prisoners, explained that he was providing iudicial assistance for many of the prisoners were considered their cases and move them in the procurators and courts, through the installation of lawvers to defend them. The foundation earned Indian prisoner issue. Manish Kumar Rai eon, who was a prisoner in Central reform of Sana'a-Alamanah Sana'a since 06/22/2011 on charges of treason secretariat. After the arguments adopted by the foundation for a year to earn the issue of the Indian prisoner where the court accepted the resumption of the plaintiff and directed his immediate release and his innocence of the charges against him, unless imprisoned for another case.

For his part, the Attorney-General welcomed the workshop confirming the importance of addressing the issues of insolvent prisoners assuring more care about them as the prison is punitive not reprisal facility.

The meeting was attended by board member, Mr. Ali Alasemi and Mr. Yahya Abid prisoner, and NPF General Manager, Fadle Obaid.

National Prisoner Foundation implemented two relief campaigns in Alhodaida governorate in May and November targeted 2500 families for some districts and villages of Alhodaida governorate, funded by Al hajj Ali Mohamed Alhabbary& Sons Group and in cooperation with the Alhodaida governorate association for Social Development and Red Sea. The other campaign of relief in Sana'a targeted 500 families of displaced people in Sana'a funded by (MTN)National Charitable Foundation in cooperation with the operational unit to manage camps for displaced in the capital Sana'a. Mr.Obaid, NPF general director, explained that the first campaign targeting those affected by disasters, floods in the districts of Alluhaiah and Alzahrah and other targeted districts Alzahrah, and other targeted districts Alzahrah, Alkawuyah, Zaidi, Alguenaos, the port, correctional Central in the impartiality, the families of the Zaidi prisoners, and the coastal Haimah.He noted that the two campaigns targeted Tehama people Relief, who are threatened by famine due to disasters and the difficult conditions that prevailed in our country because of the unjust war in Yemen.He clarified that first campaign implemented in coordination with leadership of Alhodaida governorate Executive Unit and the camps of the displaced persons to provide a data base of the affected of torrents disasters who exposed their property from homes and

livestock and agricultural land for snowplowing torrents. They're provided with 1,500 food baskets consisting of flour, sugar, and cooking oil.NPF Project and Programs Manger, Mr. Mansour Alsarhah pointed that the second relief campaign has been distributed in the first several points targeted Alzahrah district for 410 families included a number of villages in the directorates of Alzahrah, and village of Bani Jamea Alluhaiah and Nu'man village.He noted that the campaign was distributed in the second point relief materials in Al Zaidi directorates and Alkanawis targeting 487 families from the various regions and families of Al Zaidi prisoners.

He noted that the third point has been distributed in the villages of coastal Haimah targeting 900 affected families in the villages of Alghgairah, Alsadah. Almanheesh, Almyna'a, Alnhary, Alwady, Alward, Alwaly, Al- Sateeq, Okaish, Aljameel, Alhorofah village.

He pointed out that the campaign distributed in the second point of relief items in the departments of AlZaidi and Alquenaos targeting 487 families from various regions and the families of the Zaidi

He also noted that the second relief campaign included the central province of Hodaida Correctional 200 bags of wheat, 200bags of wheat, and 200 bags of flour.

campaign included distribution of 3,000 bags of wheat 50kg, 2000 bags of flour bag weight of 35 Kg and 1000 bags of rice weighing 10kg. Director of programs and projects pointed out that the national prisoner Foundation distributed in February 500 food baskets for displaced persons in the capital secretariat through National Relief launched by the foundation in April 2016 funded by (MTN) charitable foundation in cooperation with the operational unit of the Department of the displaced persons camps.

Humanitarian Situation in Yemen



Food Insecurity is Widespread

As acute food insecurity prevails in vast areas of Yemen, 19 out of 22 governorates are exposed to famine, National Prisoner Foundation warns that the situation in the affected areas likely to deteriorate further if the war in Yemen continued.

More than half the country 's population live in a crisis or emergency levels of food insecurity up to 70 % of the population struggling to feed seen them affected.7 million people at least as a quarter of the population live below the emergency level of food insecurity (Phase 4 degrees on the IPC scale – scale of global food security - Consisting of five levels). This reflects an increase of 15% since June 2015 and more than 7.1 million people in the case of 3 - phase crisis.

Results of IPC clearly show magnitude of the humanitarian crisis in Yemen In a statement to Mr. Jamie Mc-

Goldrick, the UN Humanitarian Affairs in Yemen, "This is one of the worst crises in the world Coordinator has produced conflict dearly broad and devastated the country and as a result found food insecurity and indicators are still high and Unacceptable".

The main reasons of food insecurity: fuel shortages and import restrictions that have reduced the availability of basic food commodities in the country, which imports about 90% of basic foodstuffs that have. Imports of food and fuel in March 2016 had been the lowest level since October 2015 and met only 12 % of the country 's needs of fuel.

Domestic prices of wheat affected badly in time it was higher between 12-15 % in May 2016 compared with pre - crisis levels, although global wheat prices have fallen in recent months. Agriculture paralyzed because of the shortage of

seeds and fertilizers crop production in such parts of Yemen, where earn about 50 % of the workforce living from the agricultural sector and related activities.

The country witnessed two hurricanes in November in 2015, in addition to floods and flocks of locusts in April 2016, which did not find contend and limited the ability of farmers to food production and seeking to their farms because the fear of bombarding. In the area of malnutrition of nearly 3 million children under five years old, pregnant and lactating womenrequired services of treatment or prevention of acute malnutrition, says the UNICEF organization in

their periodic reports.

Acute malnutrition (CAM) is still a serious stage in most of the governorates of the country, up to levels of 25.1% in Taiz and 21,7% in Al Hodaidah the same areas of significant decrease in the traditional fishing. About 75% decreased down to half of fishing operations compared with 2014.

Under these suffer circumstances, a UN plan respond to the humanitarian a shortfall in funding to meet the comprehensive response. Mr. Makfoldrik said "I urgently invite the donors to increase humanitarian funding so

that we can deliver more food aid to millions of other persons who are in urgent need."

National prisoner foundation invites all national humanitarian organizations and humanitarian society and the domestic and international levels toward building a better response to the importance of activating the role of civil society organizations. It emphasized to make a partnership between local and international humanitarian agencies to increase the absorption of humanitarian aid and to ensure the safety and security of humanitarian personnel and staff of the organizations of civil society working in the humanitarian field staff of civil society organizations to help displaced persons and to provide them with assistance in contributing effectively. This partnership is mandatory to face the economic damage caused by the unjust embargo imposed on Yemen and negative

effects on health, education sectors, transport communications, and the humanitarian situation deteriorating situation of more than 80% of the population who are in need of necessary and urgent humanitarian aid to overcome the difficulty of those in need and provide assistance to recipients.

Also, it invites for creation of specific mechanisms to accommodate the humanitarian aid and strengthening of the role of civil society organizations and building local capacity, coordination, and partnership between local and international humanitarian agencies to develop a plan of action to implement those mechanisms.

The national prisoner foundation emerged one of the civil society organizations working on the scope of Republic of Yemen, as a leader and specialist in male and female prisoners issues despite the difficult circumstances in which the foundation originated from the year 2013 up to date. Despite, NPF has made a quantum leap and great success since been able to achieve its development goals in relief, human rights, and humanity with balanced vision. Foundation has achieved a big number of male and female prisoners whom provided with financial assistance for their release about 378 prisoners and prisoners over the four years.

It was also provided legal consulting for nearly (2000 issues), in the case of judicial aid totaled nearly number ofbeneficiaries (51) outstanding cases of prisoners in the procurators and courts. the organization adopted in computer session the curriculum accredited by the University of Science and Technology, and certificates ratified by Ministry of Technical Education and Vocational training.













NPF Distributes Kitchen Tools on Remand Prisons in Sana'a, Builds and Furnishes Kitchen for Ibb Correction Female Inmates

Project importance seen as it meets the needs of prisoners in maintaining their health as the previous kitchen tools were totally unhealthy and caused a lot of diseases within prisoners according to doctors.

It is worth mentioning that cooking pans, cookers, spoons, frying pans, and many kitchen tools were provided.

Under the auspices of the Former Minister of Interior , M.G. Jalal Ali Alrwishan , funded by Haj. Ali M. Alhabbari under the campaign of prisons relief ,NPF provided the kitchen tools for the remand prisons , & CID in Sana'a –Alamanah in April also provided kitchen tools for the inmates of the Central Correction in Ibb province with total cost of (1,300,000).

A story of insolvent prisoner (S.A) who languished behind bars for seventeen years and while being in prison ,his mother and wife died and his kids got homeless due to inability to pay his due debt and was released

Human Program; The idea of "Human" project came as a response to the appeal of conscience toward insolvent prisoners. The project mainly aims to display impact stories of insolvent prisoners sentenced because of their inability to pay off their debts. We believe that Prisoner is a human led at times, by dire conditions, to be behind bars. He is first and last a human, either a father or mother, brother or sister, son or daughter, husband or wife. "Human Program" has had a significant impact in the community, as many people and philanthropists were affected by the humanitarian stories published by "Human Program". Thus they provided funds and a great amount of humanitarian assistance to insolvent prisoners and their families. Yemeni people showed remarkable ability to express their solidarity and compassion with prisoners, sharing with them their food and money in such dire conditions. No one can forget the moments when a released prisoner's family visited NPF the day after he was released, and how grateful they were. It's unforgettable to see the old man who donated his entire salary immediately after receiving it. The most emotional was the story of the insolvent prisoner who remained in jail for 17 years, during which he lost everything; his mother and his wife died, and his children were made homeless. Then when NPF published his story, a number of philanthropists sympathized with him, paid off the amount due, and got him released. Thus, "Human Program", adopted by NPF is an intermediary between the people and the oppressed or the insolvent prisoners. It is planned that the program continues to display a various issues related to prisoners.



Story of S.A who spent more than 17 years behind the bars during such period his wife and mother passed away and his children got homeless due his inability to pay his debt. Then, he was released by NPF

This program expressed the suffering of those people, spoke on their behalf. Represented those people who have been punished for crimes they never commit add to that the punishment they got from the community where they should not be treated like that.

Insolvent Prisoners Assistance Project



What's Insolvent Prisoners Assistance Project?

We seek, through "Insolvent Prisoner Assistance" to help insolvent prisoners to get released, paying off their private rights (amounts due to others), after they serve entire sentences and meet selection criteria and assistance conditions.

Implementation Phases:



Collecting Data Phase: In this phase, a team of NPF's lawyers carry out field surveys in central prisons and corrections on insolvent prisoners' issues and receive insolvent prisoners' issues at NPF headquarter.



Selection Phase: In this phase, a committee of legal experts, headed by Director of the Department of Legal Affairs, checks out the collected insolvent prisoners' information to select states that meet assistance conditions and selection criteria.



Phase of Reconciliation between Prisoners and Rights holders: At this phase, NPF team negotiates with rights holders to persuade them giving up some of the amounts that the prisoners due according to the sentences issued by prosecutions and courts, and tries converging views to resolve the dispute between the prisoner and the right holder.




Phase of Fundraise and Payment: In such phase, NPF launches a campaign to raise funds from philanthropists, businessmen, and companies in favor of insolvent prisoners.



Release Phase: After raising funds, NPF team pays amounts on insolvent prisoners' behalf; NPF pays through prosecutions and courts, deposit required funds in insolvents' balances at the public prosecution, or directly deliver cash payment to the right holder after the closure of the case file. Finally, NPF gets the release order.

Assistance Eligibility

- 1 Prisoner's debt shall be fixed on the basis of peremptory judicial verdict.
- 2 Prisoner due pay shall be based on legal work and the insolvency shall be proved.
- 3 The debtor shall be a prisoner under due pay.
- A copy of the judicial verdict shall be provided.
- 5 Prisoner shall not be manipulator or deceiver before or after the verdict.
- 6 Debts shall not be accumulated on the basis of crime committed by free will or for the purpose of money attainment.
- The prisoner shall not be released after paying off on his/her behalf and was jailed again due to new due debts.

Number of families of insolvent prisoners, who were released on Sunday, expressed their happiness for their being set free and for the help that NPF has done including proceeding the release procedures and paying their

The wife of the released prisoner, Faisal, said I did not expect that Faisal gets released from prison in these difficult circumstances in country due to the severe war. My hopes for improved conditions were lost, but the National Prisoner Foundation did what I couldn't expect; following up my husband's case and paying the amount he is in

She added, "Faisal is the sole breadwinner for our family and our situation throughout the three past years was very tough as we couldn't find any way to pay the mortgage of the house and find something to eat. Our lives throughout the period of his imprisonment confined to accumulated debti. Faisal's wife explained "Faisal has four children from his first wife which exacerbates the suffering of her family.

Mulatif Al-Bahloli's mother said, "life turned into hell after my son's imprisonment since he was the sole breadwinner for our family through his work on a motorcycle". She added that her elderly husband was forced to work out to provide a living, but he did not find work for being aged which made him beg. She expressed her overwhelming happiness that her son is out of jail after the Prisoner Foundation has paid the sum of money he owes, thanking the Prisoner Foundation . Al-Habari and his sons' Group, and all participants in the release of her only son.

Ali Al-Yamani's brother pointed out that the family had lost hope for the release of their brother for their inability to pay the amount of money due to the countries situa-

He noted that the family could only pay visits to their brother to prison from time to time and inspect on his situation and needs till the Prisoner National Foundation came and paid the money the prisoner afforded as the brother worked a bodyguard for the tribe's Sheihk and had lent his gun to one of his companions who didn't give it back, so Sheihk had to pay and take Ali to the prison till he repays the money. He expressed his gratitude to the Prisoner Foundation staff, Al-Habari's Group and all those who contributed to the release of his brother after three years of imprisonment.

It should be noted that the prisoner Foundation released 15 insolvent prisoners at the wrap-up of the project. The number of released insolvent prisoners increases to 135 across the republic.

Attorney General Appreciates NPF Role in Releasing Insolvent Prisoners

During a meeting attended by Attorney General, Abdul-Aziz al-Baghdadi, and the NPF general director, Fadl Obaid. Mr. Al-Baghdadi praised NPF for its efforts in supporting and helping prisoners.

Attorney General also praised NPF humanitarian work for releasing insolvent prisoners and supporting them, expressing his willingness to cooperate with NPF and facilitate its duties regarding prisoners

He confirmed that the Public Prosecution's key duty of enforcing law don't overwhelm its humanitarian concerns towards insolvent prisoners.

"A cooperation should take place between the public prosecution and NPF in terms of insolvent prisoners, as well as in terms of "Judicial Support Project" through which NPF pleads for insolvents and defend them before the courts". NPF general director stressed.

Consultative Meeting with Ibb Officials to Discuss Prisoners' Issues



NPF organized the second consultative meeting to discuss the city poisoners' state with the lbb officials. The meeting sponsored by Ibb Governor, General Abdulwahid Salah, and held in association with "SAMA", Environment Development Association, and Supreme Council for Childhood, was attended by security officials, lawyers, journalists, activists, and

Mr. AbdulhamidAlshahiri, First Undersecretary of Ibb governorate, gave a speech about the local council role in facilitating such humanitarian initiatives that cast light on prisoners issues. He expressed the local authority willingness to fully cooperate with NPF and facilitate its humanitarian and legal

FadelMohrez, NPF general director, talked about the goals of the organization concerning the prisoners' cases, especially the insolvent prisoners, and helping them according to NPF policies. Mohrezh, as well, pointed out the humanitarian, medical and living services the organization provides.

After that, the attendees watched a televised word by Mohammad Al-Habbari, the businessman and the main sponsor of the organization. The word illustrated the org. responsibilities and its achievements since it has been founded in Jan. 2013.

Lawyers syndicate Head, Mr. Fadl Hussein Al-Hassani, talked about a lot of legal notes that impede the progress of cases under trial, resulting in increased number of prisoners.

Furthermore, General Mr. Hussein TaherAbdalmogni, General Manager of the Central Correction of the city, said that the Central Prison which was built in the 1980s is currently in need to be rehabilitated and expanded especially with growing numbers of inmates. He talked about the prisoners dire circumstances due to the bad state of the prison facilities, calling for immediate support to rehabilitate it.

Further, he demanded on the urgent release of lots of prisoners, especially insolvent prisoners who already completed their sentences period, and illegal migrants, such as African prisoners, detained by the specialized authorities in preventive measures, in order to lighten the load of the only correction in the city that started to receive prisoners from neighboring provinces.

NPF Visits Remand Prison's Inmates In Ibb



NPF general director, Mr. FadlObaid, and the legal affairs manager, paid a visit to lbb remand prison on Monday 2/5/2016, where they met the prison governor, General GamilSaleh, General Saleh explained to them how overcrowded is the prison, revealing that the prison houses more than 200 prisoners while its normal capacity accommodate for 100 inmates. Such crowd comes as a result of suspending trials. He added that prisons' mattresses and blankets need to be replaced.

Mr. Obaid, confirmed NPF willingness to provide basic needs and constantly cooperate with the prison management.

The Delegate stated their comments and observations and provided recommendations to be considered.

NPF Pays a Visit to Both Allayh & Althawrah Remand Prisons in Sana'a-Alamanah

A committee assigned by the National Prisoner Foundation has paid a visit to both Allayah and Al-Thawrah Remand Prisons to check on their internal clinics and the quality of medical and lab services provided for the prisoners. NPF health Official stated that the visit

aimed to check on Al-

layah and Althawrah prisons' clinics in terms of health status, availability of medicine supplies, and the medical equipment such as labs, beds, checkups and else. He urged those



in charge of the clinic to pay more attention to the hygiene of the clinic on daily basis as dust was everywhere in the clinic stressing that may lead to many health problems and damage of medication and equipment.



The Gap Between the Law and the Prisons' Reality

Law is considered a regulation that controls the behaviors of people in the society with themselves and between them and the government. Any violation for that law is breaking the law and should be amended.

At the level of prisons the letter of the law is considered the maximum limits of rights and duties that shall be respected as they are legal regulations between the prisoner and the jailer and shouldn't be violated.

Taking an overview about the reality of the prisons according to the items of the law No.48 for the year 1991 and its amendments about the regulations of the prisons, consists of 45 articles and rules, issued by a republican decree No. 221 for the year 1999 regarding the rules of regulating the prisons and consists of 102 items, we realize that there is a long gap between the period of issuing the law and the bylaw, exceeding 8 years, as well as, there is another huge gap between the law and the reality that should be bridged especially there were some positive amendments in the prisons regulations to improve their work. However, this law may not be successful unless the current law have been applied. To understand the disorders and defects in order to find good solutions for that and to bridge the gap between the laws and prisons reality, we are going to mention the details in two main parts:

Part1: Prisons regulation letters of the law.

Part2: Prisons regulation executive bylaw

First: Prisons Regulation Law and Reality

1- The bill stipulates in Article (3) that dealing with prisoners should aim to rehabilitating them and that includes using all the educational, medical, vocational training, social service, sport, cultural, and entertainment activities and also creating the desire of living and good citizenship. In fact, the reality of applying such a law isn't there as the procedures of applying that law have stopped and should be resumed to fulfill the purpose of imprisonment.

2- The bill stipulates in Article (22) that "The prison management should care about the public health inside the prison and to treat the prisoners and provide them with heath care by bringing specialized doctors in cooperation with Ministry of Public Health". However, we find that there is default in such a law generally and in the custody, where some people are detained during the time of investigation and trial and no decisions have been implemented about their cases yet, in particular.

Prisoners should be dealt with very well as the prison doesn't only mean centralization and that's not applied at those who are in custody. However, prison includes both prisoners and those who are in custody.



All the Doctors' recommendations and observations, & instructions in terms of medical, health, precautionary or nutrition fields are binding to be implemented by the prison administration. Once inability to implement due to lack of potentials, such recommendations shall be referred immediately to the Minister for recognition and action

The prison administration shall care about the public health within prison and shall provide health care, assign doctors for prisoners in coordination with Ministry of Public Health

3- It's also obligatory by the law that physicians working in the prisons shall issue reports explaining the reality of the prisons and their recommendations about nutrition and health should be implemented as stated in the article No.(24): "The directions and recommendations of physicians regarding the healthy and nutrition conditions of prisoners must be implemented by the prison management, and if couldn't be implemented, they should be revered to the minister to direct about them". Although that's obligatory and should be implemented, but unfortunately it's not applied in reality and this is contradicts with the law and must be implemented.

Second: Prisons regulation executive bylaw

Generally speaking about the items of the executive bylaw of the prisons law we find that it consists of 102 articles in 10 chapters that explains the mechanisms of implementing the prisons law in details. Although more than 16 years, since the bylaw have been issued, have already passed, some shortages in implementing have been noticed. However, the available capabilities could be the reason for that, or other reasons may be there, but we are going to mention to the paragraphs of the law and to conduct a practical study for that hoping this may participate in facilitating the work of prisons to conduct their legal duty properly. All of that will be summarized as follows:



1- Chapter 2 of the bylaw states the duties of the prison manager mentioned in 23 points among those are the following:

a- To meet every prisoner brought to prison, or within 12 hours as a maximum, to address him about his rights and duties and also the cases that he could be shot.

This in an important point as the prisoner once he put in prison it means that he has been moved to a place ruled by regulations. The prisoners should be addressed about the regulations by the manager himself in the first day of their residence inside the prison as he is the person in charge. A prisoner should fully understand all the rules and regulations to be fully aware about the duties and to demand for them, as well as, not to make any violations for such rules and regulations. As there are a lot of prisoners, this could be an obstacle to address all of them.

Prison Manager should visit the prisoners daily to make sure that they are doing the duties they were asked to do and also to ensure their numbers, hygiene and that there aren't any illegal material with them

but this shouldn't be an excuse.

b. Prison manager should visit the prisoners daily to make sure that they are going the duties they were asked to do and also to make sure that there aren't any illegal material with them. This is also an important point stated by the bylaw to be a direct responsibility to be implemented by the manager, but not to be satisfied with the report of the workers. He (the manager) should visit the prisoners daily to check their disciplines and to check every corner of prison to make sure that everything is in order. Also he should know everything about what's happening inside the prison as there could be some disorders behind his back. However, the manager could indulge in office work or with following the salaries and wages of employees and workers affairs. There should be regulations for implementing all of that and the expenses of prison should be priority to make sure the safety of prisoners.

c. Prison manager should visit the kitchen and the bakery inside prison to make sure that the food is healthy and its distributed properly for prisoners, as well as, to make sure that the portions are enough and offered on time. Food is very important for prisoners as it's possible to imprison a person without offering him/her enough and health food based on their health conditions as there could be some prisoners >>> who suffer from diabetes or other diseases that require special kind of food as recommended by the physician in charge. This is the responsibility of the manager as stated by the law. To cut the long story short, do all the prisons managers take such responsibilities on their necks? All of us hope that the rules and regulations should be implemented.

2- The duties of the social and psychological worker inside the prison:

The executive bylaw stated the duties of social worker in three stages as follows:

First Stage: Reception and case check up:

Social worker should make a file for every prisoner in which to keep all the required information about the prisoners including personal details, physical and mental conditions and previous terrible. All of that to help the social worker following up the prisoner's case to be treated properly, and also to record any medical cased noticed with prisoners families to be recommended to Ministry of Social Affairs for help.

Second Stage: Regarding the work with prisoners and imposing duties to make them busy in their free times.

The executive bylaw made it necessary that the social and psychological worker shall make the prisoners busy in their free times using some cultural and educational programs to let them get the benefit from that as the social worker is the most knowledgeable person about the ac-

tivities that prisoners require them. Third Stage: After- leaving care:

-The bylaw stated that social worker shall also follow the medical condition of prisoner after leaving the prison to make sure that he comes back to society as a good person. The bylaw also regulated some important points regarding the prisoner's care such as:



Food is very important for prisoners as it's possible to imprison a person without offering him/her enough and health food based on their health conditions as there could be some prisoners. who suffer from diabetes or other diseases that require special kind of food as recommended by the physician in charge

- -To meet the prisoners that are soon going to be released, 2 months before release, to make weekly sessions with them and to focus on rehabilitating them to come back as good people in society after their release.
- To check the social files of the released prisoners to review their cases and to work on their external issues.
 - To contact with Social Affairs and other related organizations to set a plan for pre-releasing for prisoners to help them solving their problems.
 - To follow up the cases of those who were released in order to review their cases as that will help in solving their issues and to make sure to register that on prison's records.

All the social and psychological regulations mentioned above are so necessary as prisoners are human and should be cared about. Any disorders also should be set to make sure that a prisoner became a good person before leaving prison. However, none of the above mentioned pointed are implemented, including opening a file for every prisoner when received, helping the prisoner in solving his issues... etc. Even if some of those points are implemented, it's extremely not enough although the bylaw regulated all of that rules and regulations to deal with prisoners. Finally, we can say that all defaults and issues should be solved to provide prisoners with psychological stability, to solve their issues, and to rehabilitate them to come back to their societies as good people and resume their social and family life very well as this will help in merging them with society.

3- Prisons High Committee and to let other institutions to interfere and solve its issues:

The bill of the prisons bylaw stipulates in Article (11) that prisons higher commission shall be established and to include representatives of the concerned authorities(at least 10 institutions) and the representatives of ministries shall hold a position of deputy minister and up and the reporter is the head of the prisons departments. Also it's mentioned that a regular meetings shall be hold every two months and if needed, an extraordinary meetings shall be held. The representatives also shall exert their efforts to make a positive link with the concerned authorities and find good solutions when necessary. It's necessary to re-activate the rules of such a committee and finding solutions for any disorders that could happen.

4- Prisoners rehabilitation and

About 38 articles were mentioned in the bylaw to focus on prisoners rehabilitation and training(articles from 16 to 54). Those articles confirmed the importance of training and rehabilitating prisoners as this is considered an important point and prison is considered as a station for reforming the prisoners to come back to their societies as good people and have crafts to help them finding works to support their families. Training includes training in business, electricity, carpentry, and any other crafts that prisoners could get the benefit from. In addition, a prisoner could gain some amounts of money to support his family during the time of his imprisonment. This is a very positive point as it has material returns and physical as well. However, training and rehabilitating prisoners may keep them away of any possible deviations that could happen especially when a prisoner loses his job. The bylaw also stated the conditions of trainers and trainees to make sure that the programs are meeting the requirements and beneficial.

In reality, we realize that there is a gap between such procedures and implementing them as most of the programs and processes related to training and rehabilitating prisoners has stopped causing a gap between the law and reality. So, it's necessary to re-activate that laws and regulations as fast as possible and without any delay for that is very important to achieve the purpose

The other articles of the executive bylaw focused on some other important points related to sorting and housing the prisoners according to their crimes, ages, and conditions. It also focused on the procedures that shall be implemented to keep the prisoners save at the time of imprisoning based on the related laws. It's very necessary to reform the prisons system thoroughly and making a priority for that by all the concerned authorities. If such reforms have been conducted, a prison could be a good place for rehabilitating and



programs and processes related to training and rehabilitating prisoners has stopped causing a gap between the law and reality. So, it's necessary to re-activate that laws and regulations as fast as possible and without any delay for that is very important to achieve the purpose of imprisonment which is reforming the prisoners to be good and positive people in their societies and families

5- The rest of articles of the executive bylaw of prisons regulating:

changing bad criminal people. However, it could be the opposite if prisons were left in the same terrible situation and this unfortunately could threaten the society.

Conclusion:

All what have been mentioned before are only a little points that explains the gap between the prisons laws and the reality. This gap should be bridged through evaluating the situation of prisons in general to make sure if they really implement the laws and the reasons as that could enable the concerned authorities amending any disorders as fast as possible. However, if such disorders are still there, this may threaten the society and make the prisons illegal and don't fulfill the goals they were built for.

Prisons in Yemen are places of where human rights are broken. It is there rare to find someone interested in humanitarian issues.

NPF was founded to mainly do: alleviate suffering in Yemeni prisons, rehabilitate prisoners, provide humanitarian aids to prisoners' families, offer advocacy for released prisoners, and take care of female prisoners and children accompanying them. NPF's programs are not limited to financial and material support, but also to provide rehabilitation programs; social, psychological, health and educational. NPF as well conducts studies on the causes, motives, and factors contributing on crimes. Such studies help to take preventive measures against crime, address its effects, and to raise society awareness about it, in order to keep the social construction of the Yemeni community.

Various forms of suffering inside prisons, that prompted us to establish NPF, will briefly be reviewed below:

In terms of advocacy: many prisoners finished their sentences period but still behind bars because of amounts due to others, although the law criminalizes such state. Although the law requires that the prosecution should appoint a lawyers for each accused who can not defend himself, Many prisoners are unable to defend their rights because of their inability

to pay the costs of hearing before prosecutions and courts. Prisoners face as well another kinds of violations such as physical and verbal abuse.

In terms of culture and education: The moment a prisoner is put in jail, he lose his rights to further education. Even in case that a prison has internal school, the education quality is very low compared to other schools.

Deteriorating state of prisons' libraries, or rather lack of them, increase gravely the cultural and educational sterility.

In terms of health: prisons' environment is completely unhealthy. The health facilities lack medicines, items and health supplies. Prisoners are also vulnerable to infectious diseases due to lack of guarantine facilities.

In terms of psychological health: Lack of

psychological support programs, training and rehabilitation programs, and another cultural & sport activities, caused a loss of morale and an emergence of mental illness within the prisoners.

In terms of shelter and non-food items: Many skin diseases such as scabies, and allergies, spread through a prison due to old & worn out mattress and blankets. that became unfit to human use. The lack of appropriate and clean kitchenware in Prisons' Kitchens causes a lot of infectious intestinal diseases among the prison-

Another diseases afflict prisoners because of the huge amount of garbage and waste through prisons.

Cold diseases emerge among prisoners due to lack of blankets, and their inability to buy winter clothes.

In terms of water, sanitation, and hygiene: Prisons suffer from full collapse in water supply, with old and septic tanks, and rusty pipes, exacerbating the suffering of the prisoners to get safe drinking water, especially with lack of water purification filters.

> Prisons suffer also from poor sanitation which became an ideal environment for insects and infectious diseases.

Prisoners suffer from a lack of household items that help them to collect water and to maintain their personal hygiene.

In term of nutrition: . Prisons suffer from overcrowding of prisoners with not enough budget to cover their needs.

Suffering is inside as well as outside prisons, as due to ongoing war, Yemenis witness a growing deterioration of food security and increasing number of families that lose their ability to purchase the main needs, among them the prisoners' families, especially families that their breadwinner is a prisoner.

ing as there are more than one legal institution detains people and make them in custody and this is illegal as the law specified the official and unofficial authorities that are allowed to detain people under the supervision of public prosecution. It's not reasonable that all the official authorities can detain people without any legal specialization. However, detaining people and citizens by Sheiks and high ranking officials is considered a violation. As an examples for that it was found at one of the police stations a person that was detained according to the directions of a public hospital as he doesn't bear paying the fees for hospitalization and fees for the operation has been done for his father. Accordingly, he was referred to the nearby police station to be put in custody till he pays the required fees and he was detained for more than ten days. It was also noticed that the manager of the hospital asked to detain some other citizens before for the same reason.

It's necessary to think about detaining citizens and if that is illegal or not. So we realize that it's illegal to do that from the humanitarian and constitutional perspectives. Also detaining people inside police stations illegally is wrong and should be corrected according to the law and also to abide by the duration specified by the law.

Public prosecution is considered an independent judiciary authority to protect society. The criminal procedures law made it necessary that all police stations shall proof any case in a private record and to keep the public prosecution updated about that. The law quoted in its article No. 106 that" Everyone who is in charge of police stations shall record all detention cases in a private record including the official's name and title and the way of doing that with the date and hour and the reason of deten-

tion, the time once that has done, and to submit a copy of the record includes all the cases with details on daily bases". However, the criminal procedure law also made it necessary that the public prosecution members shall visit the place of detention to make sure that the procedures are legal and to release those who were detained illegally and to refer the detainees to the concerned authorities. According to the article No. 13 of the criminal procedures law it's stated that" Everyone has detained a person and imprisoned him without any legal reason or at any place rather than the specified place shall notify a member of the public prosecution who shall move immediately to see the detained person and release him immediately and the same with any other similar cases. But if it's proved that the person was detained legally, he shall be sent to one of the penalty institutions

Taking an overview about what's happening inside the prisons, we realize that there are a lot of violations committed against prisoners and all the concerned authorities- such as public prosecution as it's considered a high judiciary institution- shall put an end for that(protecting people from any violations or detaining them illegally) according to the law.

If the public prosecution exerted its efforts in doing all of that, the violations will be limited before aggravation.

7- Prisoners rights:

Some of the prerequisites of human rights that should be implemented when detaining or imprisoning people are to provide them with the necessary food, medicine, and mattress to keep their dignity as they are human. Government. through its security apparatuses, should provide prisoners with clean mattress, blankets, clean toilets, necessary medical services, and any other rights as this is considered a minimum prerequisite based on international standards.

Finally, We hope that all violations in prisons and custodies should be reconsidered according to what we have mentioned above as such violations are considered dangerous violations against human rights and should be put an end to them to fulfill the purposes of imprisonment represented by releasing prisoners as good and rehabilitated people.

Constant Abuses and Violation Against Law

Linquistically the violation is derived from "shortage" which means to be a shortage in the rights that should be reimbursed by the concerned authorities. So prisons violations are the shortages in reimbursing the rights by the administrative and legal authorities toward prisoners. Taking an overview in the situation of prisons and the violations committed inside them has caused accumulating the prisons with prisoners as they are overloaded. The reasons behind all of that terrible are summarized in the following points:

1- The concerned authorities don't commit with the duration of custody and imprisonment:

As it's very critical to keep a person in custody or limiting his freedom, as this could be harmful physically and mentally for the prisoner and also his familv. the law has restricted the capacities of administrative and legal authorities in this regard. So any violation against that is considered violation against the law and constitution and human rights

Unfortunately in reality is totally the opposite and the disorders that happen are considered a violation for human rights and making a person in custody and limiting his freedom is considered a crime according to the law. For more details we mention the following two


a- The validity of the administrative and security apparatuses:

In its article No. 48- item (c)- the Ye-

meni constitution quoted that" Every person has been captured temporally as suspicious in committing a crime, shall be submitted to judiciary within 24 hours of capturing". Focusing on that, we find out that the duration is restricted to be only 24 hours and after that he\she shall be referred to prosecution or to be released. As freedom limitation is considered a dangerous behavior, that was confirmed in the law of the criminal procedures issued according to the republican decree No.13, 1994. The article No. 73 of that law quoted that:" Every person has been captured temporally as suspicious in committing a crime, shall be submitted to judiciary within 24 hours of capturing as a maximum.... etc."



His humanity created the smile of prisoners:

Although he was a busy businessman, he kept on doing charity and humanitarian works especially prisoners that are kept in prisons for not having enough due amounts to pay to be released. He has spent much amounts of money to release many prisoners through paying the due amounts requested from them in cooperation with Prisoner Foundation as he played a vital role in succeeding its charity deeds. He also helped many female prisoners and their children through providing them with their monthly necessary requirement. Inside the prison he participated in providing prisoners with food, medical, and cleanliness requirement

in all prisons and custodies in Sana'a and some other governorates. Some of his charity works in prisons also are represented by providing foodstuff for 6 months, financing the cleanliness campaigns for prisons, maintaining sewage systems, furnishing prisons kitchens, and financing some social care units in Sana'a. The late philanthropist provided the Social Guidance House based in Sana'a with a fixed monthly budget covers the operation, cultural and social activities expenses. He also financed treating some of poor sick prisoners in cooperation with The Yemen International Company for Food Manufactures. Some other charities that he had financed are helping a prisoner that was suffering from AIDS and another one who has done an operation for his eyes and many other sick people were also helped by him. He also participated in some other charity deeds like Eids meat project that is implemented annually targeting

prisoners and their families in Sana'a and other cities as well. In addition, he didn't even forget the idea of prisoners privacy with their families when they come to visit them, as well as, he have supported some activities call to respect-

ing the prisoners and supporting human rights.

Philanthropist for all:

The late was an examples for a businessman that loved all people and helped in covering their needs as he supported many poor families, charity organizations, orphans, and also supporting some poor families to be treated in private hospitals in Sana'a and some other cities and others who suffer from difficult diseases to travel outside Yemen for treatment. He also supported some bakeries in Sana'a, Thamar, and Amran with huge amounts of flour to make food for poor and needy people. The late also participated

in building and rehabilitating mosques in Sana'a, Hodieldah, Amran, and other cities in Yemen. He provided the Great Mosque and the surrounding areas with solar system for lighting and also provided the mosques with 5000 liter of diesel for its generator monthly. The late also participated in digging artesian wells in Arhab and some other surrounding districts. He also has some participations in marriage projects and helping displaced families in Yemen because of the aggressive war and also supporting the families of martyrs.

Charity participation in Education:

As he used to support many different projects in various sectors, education has also received some of his charity deeds as he financed building a great hall for meetings and lecturing in the Faculty of Education in Arhab, installing the machine system for Faculty of Arts, sup-

porting blind people, deaf and speeches centers at Sana'a University, providing the Computer Department at Sana'a University with some PCs, and also for the management of Library Department. However, the last educational charity

project was establishing Mechatronics Engineering Department at Sana'a University, Faculty of Engineering with all of the required tools and machines. All of that projects mean that the late has participated in developing education and enabling students receive modern sciences.

Clear participations in supporting and enhancing the national economy:


The late had been working in business since his child-hood as business was the craft of his ancestors who used to sell grains. Later he established a famous group of companies that participated in enhancing the national economy and predicated in stability of local food prices especially for flour and grains. Additionally, he has other participations in this regard such as establishing productive farms, contraction, shareholding in some local banks, and some activities in importing foodstuff so all of those participations played a great role in supporting and enhancing local economy.

Generous health participations:

The late philanthropist has also participated in supporting some medical works such as building a desalination station for renal dialysis with all the required equipment, rehabilitating the emergency department, preparing the cafeteria in the hospital, and providing the hospital with a modern ultrasound set for x-ray department. His efforts in supporting the medical services have also reached the Military Hospital in Sana'a as he participated in receiving the injured people who come from war districts, as well as, patients from different areas in Yemen who come for treatment. Coming to Alsabean Hospital in Sana'a, he also financed building and furnishing two new floors on the hospital. He also prepared 8 operation rooms for delivery and some other operation rooms for children and other sections like ICU. This participation played a vital role in supporting and operating such hospitals to cover the shortages.

Participations in sport sector:

The late was very keen in hearing poetry and Islamic and folklore chanting so he supported poets, educated people, chanters, media men. He provided some poets and young people with monthly salaries and also financed printing many poetry divans, printing the agricultural guidance books as he fully understands the good rewards for all of that deeds. The late also supported different clubs in many different cities in Yemen, participated in honoring players in some local and international championships, and supported some players through providing the medical services for them and their families.

Insolvent Prisoners..



What's Insolvent Support Project? Who's insolvent prisoner? How their stories reach NPF and how it do help them? Below we find out these questions' answers.

Insolvent prisoners' issues in Yemen prisons are complex issues, which are carrying the sense of offense, injustice and social tragedy, as well as being forgotten by the community. In insolvency cases the parties are often a creditor and a debtor, who stand before courts with no difference between them as they are both victims.

espite the suffering of insolvent prisoners, they found no one to help them till NPF was established to adopt their issues and bring joy to their families.

NPF began to work tirelessly to get to these goals. It seeks to do it according to humanitarian standards, so first, it began to conduct a survey in several prisons in Yemen to document the insolvent cases and build its humanitarian and legal plan.

It also set up criteria to select the insolvent prisoners being worth to receive NPF's support to be released.

Standards were legal and humanitarian such: First, targeted prisoner should not having deliberately committed an offence, or a criminal case. Then, another factors and standards contribute to the selection process: Is the prisoner the only breadwinner of his family? How many are his family members? Does the prisoner attend a school or university? How is his physical and psychological state?

As a part of selection process, NPF listen to the details

of the case from the prisoner himself, and his family, and listen to his opponent, then collect details from the trial's document and the sentences passed against him by the court, and finally decides to support and starts to call supporters to fund such humanitarian case.

NPF started, in 2016, thought its standards, to select insolvent prisoners, pay amount they due to others, and release them. Such project aiming to bring smile to released prisoners and their families, was funded by businessmen, so far, NPF has been releasing 138 insolvent prisoners since 2006, paying 130 million on behalf of

NPF seeks that the support curve of such projects continue to increase, and hopes in current year to achieve more of success in terms of insolvent prisoners to alleviate their suffering.

So, NPF appeals all businessmen, and donors to support its efforts in order to get insolvent prisoner released and bring smile to their children's faces.

charitable people aims at: obtaining reward from Allah and drawing smile on faces of people in need.

Alhaj M. Al Habbari's Trading group doesn't hesitate to provide humanitar ian assistance for prisoners and other people in need. Recently, Al Habbari Trading group has provided funds of YR 27 million for prisoners in Criminal Investigation Prison, and another four prisons in Amanat Al A'asima.

We all know the critical humanitarian situation experienced in Yemen, which has reached its worst by 2016. All government facilities, specially prisons, are suffering deteriorating conditions; lack of vital assistance, health care items, food, hygiene items, electricity, and spreading disease due to lack of enough food, and shortage of hygiene materials, and not to follow cases of sick prisoners.

Since 15 years prisons lacks for maintenance, thus the sewage flowed abun-



dantly inside.

Sajeen Foundation launched a distress call for prisons, and as usual, Al Habbari business group was the first to respond and began to provide to jails the integrated Solar and food which was enough for six months, then it conducted a campaign of maintenance and cleanliness in prisons, in addition to providing all the cook equipment.

The campaign restored electricity for prisoners behind bars, provided them a clean environment that protects them from diseases, offered them the food they need to continue their lives until they return to a life of freedom, and also provided the kitchens items to make prisons more suitable for the prisoners'

The campaign -crowned with great success- was considered as an additional achievement of Sajeen Foundation and Al Habbari business group.

There are many prisons in Sanaa and other governance which need to similar campaigns. NPF plan to launch such campaign during the new year and is waiting for the donors to provide financial backing to contribute returning hope and smile on faces of prisoners and insuring a decent life for those who were behind bars deprived of liberty.

What Then?

Can anyone deny that unemployment is the key reason for crime, especially robbery?

"What then?", We all inquire after National Prisoner Foundation's efforts to release a prisoner.

Manish, Justice Story

As a prisoner, when observe the situation outside the jail grids, I see the days, months and yearsofchange inthereconstruction. On this land, I behold the sense of my country.

he sunlight reminds me of my motherland, India. The rain plops gently as it does in my country; even though. they say that this is not your country, but I feel the opposite. Like an Indian movie, I am imprisoned without guilt in a foreign country.

With five years in jail, the accused who cannot speak Arabic; therefore, cannot say I am not guilty, is charged with no quilt or evidence.

His silence is the cause of being imprisoned for years; however, he had a prosperous job in one of the high-ranking companies. Owning two children and wife, they waited for him to return home, but eventually he did not. Thus their sufferance prevailed as his children guitted attending their private schools, and the most stricken of all that they sometimes could not afford something to eat.

Our story of this young Indian is not a movie but the truth. Manish who converted to Islam in 2000, got married to a Yemeni Muslim woman, fathered two children and lived thrilled in his second country, Yemen. His heart was broken when he had announced his conversion to Islam as his family rejected him, his first wife divorced him and took their children away from him and even his is not allowed to meet his mother. Manish insisted on continuing the way of God in Islam and was gifted a great work, good sons and a wonderful wife.

At his work, Manish's dream of a beautiful and prosperous future was stolen through the hatred and envy of people who fabricated him a guilt he did not commit and was thrown in jail for five years. When he was asked in the Court of First Instance, Did you embezzle these amounts of money from the company? He did not know what was he accused of, silence was his reply, which is the leading reason for residing in prison for five years.

He had always dreamed to see the light of truth and began to learn to acquire Arabic in prison, but when learnt, it was late since the authorities had forgotten him, and his wife could afford him an attorney again.

His smile and hope in his God, the Lord, insured sending mercy and joy at the hands of supporters of the National Prisoner Foundation, which began taking the case to a Court of Appeal. Mainsh was able to speak and managed to justify and revealed the truth.

Also the court found out that Manish is not guilty but innocent of the charge against him; therefore, he was released to his children, second country and second wife as God's justice along with the efforts of National Foundation for Prisoners were the paid off.

When Manish tells his long sufferance story, you tend to hug him and say, 'Manish, I am proud of you as you stood against injustice'.
